### PRIVACY ACT STATEMENT

**Authority:** The information requested is authorized by the National Wildlife Refuge System Administration Act (16 U.S.C. 668dd-ee) as amended and the Refuge Recreation Act (16 U.S.C. 460k – 460k-4).

**Purpose:** The collection of contact information is to verify that the individual has an eligible permit to hunt on one of the National Wildlife Refuges that is designated for migratory bird hunting.
